#### Admissions Policy (AP) of the Graduate School of Global Humanities and Social Sciences (GSGHSS) Doctoral Course,

#### **Department of Global Humanities and Social Sciences**

#### 1. Philosophy of Nagasaki University & Educational Philosophy of the Doctoral Course

Nagasaki University contributes to the improvement of a well-balanced society through the inherited traditional culture rooted in Nagasaki, cultivating fertile creativity in students, and developing innovative science for world peace.

In relation to the various problems the multicultural social situation of the 21st century has created and based on advanced and specialized knowledge of the global humanities and social sciences, we aim to ascertain the essence of the problems, propose diverse solutions, and train researchers and highly-skilled professionals who are equipped with international communication skills and can contribute to generating and disseminating the values 21st century academia needs, while building a world that is sustainable in terms of life, mind, and social culture.

#### 2. Desired Applicants

Based on the educational philosophy, educational and research aims, the DP, and the CP, we seek students with the following qualities:

- (1) Literacy and knowledge of the humanities and social sciences.
- (2) An ability to understand and empathize with the 21st century multicultural social situation characterized by an asymmetrical and unequal society, growing risks associated with the unequal distribution of resources, and friction and conflict between ethnic groups, religions, cultures, nation states, etc., which are creating various complex problems accompanying greater intersection and convergence in the world.
- (3) An interest in interacting with people from various backgrounds in the world at large and contributing to developing a global society and global welfare

#### 3. Basic Applicant Selection Policy

We conduct four types of entrance examinations: General, Professional, International Students, and Internal Advancement. Please do not fail to contact your prospective supervisor in advance before submitting your application. Consult them fully about your entrance examination, the content of your research, and the language in which guidance will be provided.

#### 4. Applicant Selection Method

In general entrance examinations including those for professionals and international students and regarding the selection of students advancing to university, we select students who possess an education in and knowledge of global humanities and social sciences. The relevant entrance examination will be determined and judged comprehensively based on the application documents and performance in an oral test. We will use the research plan, research results from the master's thesis, etc., and the academic results certificate as the basis for the oral test.

#### 2. Entry Requirements

[Applicants category: General, International student, Professional]

For those who fulfill any of the following requirements.

In addition to any of the following being applicable, applicants under "Professional Admission" must be employed at the time of entrance and have the consent from their employer.

Applicants under "International Students Admission" must be non-Japanese citizens, (excluding foreigners with permanent residency permits) who fulfil one of the following requirements

- (1) A person who has obtained (or are expected to obtain by March 2026) a master's or a professional degree.
- (2) A person who has been conferred (or will be conferred by March 2026) a master's degree or a degree equivalent to a professional degree in countries other than Japan.
- (3) A person who has been conferred (or will be conferred by March 2026) a master's degree or a degree equivalent to a professional degree in Japan after the completion of a required correspondence course, conducted by an authorized school outside of Japan.
- (4) A person who has been conferred (or will be conferred by March 2026) a degree equivalent to a master's or a professional degree after completing a postgraduate course at a foreign education institute in Japan, which is recognized by the Ministry of Education, Culture, Sports, Science and Technology Japan.
- (5) A person who has completed the courses from the United Nations University and has been conferred (or will be conferred by March 2026) a degree equivalent to a master's degree.
- (6) A person who has completed or will complete the education program at a foreign school, the United Nations University or an educational facility specified in (4), and those who have passed or are expected to pass by March, 2026 the examination as well as the preliminary screening test prescribed in Article 16 of the Establish Standards of the Graduate School and have had their academic achievements recognized as equivalent to or greater than that of a master's degree. (See "3. Preliminary Screening")
- (7) A person who is specified by the Ministry of Education Culture, Sports, Science and Technology-Japan (1989, Ministry of Education, Public Notification No.118) as follows:
  - a) Persons who have been engaged in research for more than two years at a university or research institute after their university graduation and have had their academic achievements recognized as equivalent to or greater than that of a master's degree. (See "3. Preliminary Screening")
  - b) Persons who have been engaged in research for more than two years at a university or research institute after completing sixteen years of required school education overseas, or completing sixteen years of required school education by correspondence course conducted by foreign countries within Japan, and have had their academic achievement recognized as equivalent to or greater than that of a master's degree awarded by GSGHSS, based on the outcome of the research, etc. (See "3. Preliminary Screening")
- (8) A person who is deemed, through the individual preliminary screening, to have academic ability equivalent to or greater than students with a master's degree or professional degree and will be at least 24 years of age by March 31, 2026. (Refer to "3. Preliminary Screening).

Note: Applicants who apply according to (2) through (8) above must contact the GSGHSS Student Affairs Section, Administration Division for School of Global Humanities and Social Sciences and Faculty of Education, Institute of Humanities and Social Sciences Administrative Department, Nagasaki University at least one week prior to the deadline for submitting the preliminary screening.

#### [Applicants category: Internal Advancement Student]

Students who will have completed master courses at Nagasaki University by March 2026 and wish to pursue doctoral studies at GSGHSS.

#### 3. Preliminary Screening

Those who intend to apply under the entry requirements between (6), (7) or (8) are subject for screening prior to acceptance of their applications. Preliminary Screening is primarily done with the submitted documents, though some cases may involve an interview. If an interview is needed, notification will be sent directly to the applicant. #### 4. Application Procedures

(1) Examination fee payment period From November 25, 2025 to November 28, 2025

(2) Application period

From November 25, 2025 to November 28, 2025; the application documents must arrive no later than 5:00 p.m.

- 1. When applying, make sure to contact your preferred supervisor in advance and fully consult them about your entrance examination, the content of your research, and the language in which guidance will be provided. (See III. List of Supervisors & Main Research Themes)
- 2. If bringing the documents directly to the university, they will only be accepted between 9:00 a.m. and 5:00 p.m. (except between 12:00 noon and 1:00 p.m.). If mailing the documents by post, the application documents **must be sent by registered express mail** in a 240 mm x 332 mm envelope (called "Kakugata Nigo" in Japan) and arrive at the university by no later than the application deadline (time and date).
- **3.** Be especially careful if remitting the examination fee on the application deadline date because all of the application documents must be delivered by 5:00 p.m. on the same day after the payment has been made.

Please make sure that all information entered is correct. The admission of a successful applicant will be canceled if any entered information is found to be false.

#### 6. Selection Process

The oral test will be given in English only to applicants who wish to have an academic supervisor who is \[ \text{completion in English only possible} \] in the list of academic supervisors & main research themes on pages 15 to 20, Section III.

The selection process is the same for all examination categories: the general entrance examination, entrance examination for professionals, the entrance examination for international students, and the selection of students advancing to doctoral studies. The process is based on applicants' scores on the oral test, and successful applicants are determined in order of the highest score. However, applicants will not be accepted if there is a significantly low score in any of the evaluation items (specialized knowledge, interest and motivation in conducting research, and outline, originality and novelty of research theme and plan) in the oral test.

#### Oral test (oral test to examine the contents of the application documents)

In the oral test, based on their submitted research plan and other documents, applicants will be asked to explain their master's thesis or alternative research achievements, research theme, and plan for research after admission. This will be followed by a question-and-answer session in Japanese or English to assess their specialized knowledge, interest and motivation in conducting research, as well as the outline, originality and novelty of their research theme and plan, the language skills required for each applicant's research project, and communication skills needed in practical settings in the humanities and social sciences.

#### 8. Notes in Relation to Making Applications for Enrollment

- (1) Incomplete application documents will not be accepted.
- (2) Once accepted by the university, no changes to the application documents are permitted for any reason. Application documents that have been accepted will not be returned for any reason.
- (3) An admissions offer may be revoked if submitted application documents are found to contain false information, submitted certificates are found to have been obtained through improper means. The same shall apply if any improper actions take place pertaining to the application.

#### 1. Announcement of Successful Applicants

#### 2. Enrollment Procedures (Overview)

- (1) Enrollment procedures and enrollment fee payment periods From February 6, 2026 to February 13, 2026
- (2) Enrollment fee 282,000 yen
  - 1: The enrollment fee will not be refunded once payment has been made.
  - 2: Tuition (535,800 yen for the academic year) will be remitted in two installments by account transfer. Tuition for the first semester (267,900 yen) will be remitted in April, and tuition for the second semester (267,900 yen) will be remitted in October.
  - 3: The tuition amount is subject to revision. In the case that the amount is revised while a student is enrolled in the university, the new tuition amount will be applied when the revision is made.
  - 4: There are tuition waver and deferred payment systems in place for the enrollment fee and tuition. Details can be found in admission procedures-related documents.
  - 5: Those who are scheduled to complete the Master's Course at Nagasaki University in March 2026 are not required to pay the enrollment fee.
  - 6: International students on Japanese Government (MEXT) Scholarships are not required to pay the enrollment fee or tuition.

Applicants may receive notification of an additional admissions offer if a spot opens up in the admissions quota (number of students to be accepted) due to a successful applicant declining their admissions offer or other such circumstances. Therefore, unsuccessful applicants should stay readily reachable as well as prepared to give an immediate response as to whether they will accept the offer. Note that the applicants will lose their additional admissions qualification if they cannot be reached.

Furthermore, if the filling of vacant spots is difficult to achieve through the aforementioned additional admissions, an additional round of student recruitment may take place according to a new schedule. In such an event, an announcement will be made on the GSGHSS and elsewhere.

#### 4. Scholarships

Enrollees may utilize the scholarships offered by the Nagasaki University and other student financial aid organizations.

#### 5. Degree

Those who complete this course and its major will receive the following degree:

Doctor of Philosophy in Global Humanities and Social Sciences

#### 6. Long-Term Course System

Long-Term Course system allows students who are difficult to complete their studies within the standard course term (3 years) due to circumstances, such as work commitments, to cover the curriculum systematically over a certain period that exceeds the standard course term.

The GSGHSS recognizes a maximum enrollment period of 6 years.

If permission is granted to utilize this system at the time of enrollment, the total amount of tuition to be paid during the standard course term of this program (3 years) will be paid each semester during the term of extended enrollment in equal installments according to the recognized extended term (total amount divided by the length of extended enrollment recognized). Students who are permitted to make an application for extended enrollment are students whose circumstances make it difficult to complete the course within the standard course term and to whom any of the following apply.

- (1) Anyone who have full-time employment and are working
- (2) Anyone engaged in housework, parenting, caregiving, or are in similar circumstances
- (3) Anyone with disabilities
- (4) Anyone recognized as having circumstances commensurate with any of the above

Those who wish to make use of the extended enrollment system must first consult their prospective supervisor in advance after which a request should be made to the GSGHSS Student Affairs Section, Administration Division for School of Global Humanities and Social Sciences and Faculty of Education, Institute of Humanities and Social Sciences Administrative Department, Nagasaki University.

## <About the Five Research Fields (Systems) Offered by the Department of Global Humanities and Social Sciences Doctoral Course>

The objective of these fields is for students to develop highly specialized knowledge and creative abilities in Multicultural Society Studies and to cultivate human resources who aim to enter the Department of Global Humanities and Social Sciences Doctoral Course. These five research fields are based on the five course groups in the Master's Program (Global Studies, Linguistic Diversity, Japan, Nagasaki and Asian Studies, Policy Science, and Nuclear Disarmament and Non-Proliferation) pertaining to various problems in the multicultural social situation of the 21st century. They will deepen students' expertise in those fields even further, and are necessary for students to acquire the abilities specified in the Diploma Policy. Furthermore, in addition to the aforementioned responsibilities of a national university located in Nagasaki, including efforts to abolish nuclear weapons and promote peace, preservation of cultural assets and traditional performing arts, and the development of research on local history, the Doctoral Course will also realize the integrated creation of "the global world with localities." which is a characteristic of the Doctoral Course. The Sociocultural Research system, Linguistic Research system, and the Japan, Nagasaki, and Maritime Area Studies and Asian Research system are particularly concerned with the cultivation of a more advanced ability to discern the essence of various complex problems in the multicultural social situation of the 21st century, while the Public Policy Research system and the Abolition of Nuclear Arms and Peace Studies system are concerned with the cultivation of a more advanced ability to present various solutions to solve problems. These abilities to discern the essence of problems and to present various solutions to solve problems are indispensable in fostering independent researchers and advanced professionals based on highly specialized knowledge and creative abilities in multicultural society studies.

The skills that students will develop in the five research fields (systems) are as described on the following page.

The Japan, Nagasaki, and Maritime Area Studies and Asian Research Department	As opposed to previous literary-centered Japanese research, we transpose previous results of Japanese research within East Asia and the world, and, from the perspective of Japan and the Nagasaki hub, given their fluidity in terms of people, situations, and things, we explore transdisciplinary Japan, Nagasaki, and maritime area research and Asian research. In other words, we deconstruct the Orientalist perception (the construction of the other as the subject of exploitation and aid and as an inferior existence to give superior significance to the self and the point that egocentric self—other perception of this kind is deeply rooted in the nature of modern academia based on the discourse of controlling the other) through theory and verification, and while focusing on the world through globalization and the decentralization and multi-centralization of academia, we explore a new relationship of self and other that will be the basis for the study of global humanities and social science in the 21st century.
Public Policy Research Department	In relation to international public policy, as well as understanding the roles and limitations of the respective actors at each stage of the policy process in order to set and design projects and form and determine, implement and manage, and evaluate policies, we critically examine current international relations and explore the formation and realization of global public value
The Abolition of Nuclear Arms and Peace Studies Department	Focusing on the international situation, we analyze and consider a security framework that is non-reliant on a nuclear deterrent and the relationship between the peaceful use of atomic energy and nuclear non-proliferation, and, by cultivating a specialization in nuclear disarmament and non-proliferation, we explore the formation and realization of a world without nuclear arms.

## About the Establishment of the Department of Global Humanities and Social Sciences Doctoral Course

The Department of Global Humanities and Social Sciences Doctoral Course at this Graduate School aims to identify the essence of problems and present various solutions to solve problems, based on highly specialized knowledge of multicultural society studies regarding a variety of issues caused by the multicultural social conditions of the 21st century, and to train researchers and advanced professionals with international communication skills who will contribute to the creation and propagation of values required of 21st century learning, as well as the construction of a sustainable world of life, spirit and social culture. In other words, the further advancement of multicultural society studies aspires to build an interdisciplinary comprehensive research field in the humanities and social sciences, based on the premise of diversity, by connecting the global and local through interaction with different cultures and societies and bringing together disciplines that are interested in life, spirit, and social culture, while simultaneously taking a holistic view of the world. Taking this into account, through the refinement of multicultural society studies at a higher level, the department aims to identify the essence of problems and present various solutions to solve problems posed by complex issues in multicultural social situations, and to train researchers and advanced professionals with international communication skills who will contribute to the creation and propagation of values required of 21st century learning, and the construction of a sustainable world of life, spirit, and social culture.

## Policy for Completion Certification and Granting of Degree (Diploma Policy (DP))

After acquiring the designated units by studying in this course for 3 years or longer and receiving the necessary research supervision, students who possess the following skills (1–3) in relation to the problems of the 21st century multicultural social situation and who also pass the degree dissertation review and final examinations will be conferred the doctor's degree (Doctor of Philosophy).

- 1. Conduct any of the following research and demonstrate highly specialized knowledge and creative abilities related to global humanities and social sciences.
- (1) Sociocultural research that aims to establish theories on co-existence and diversity
- (2) Linguistic research that aims to devise a fundamental solution entailing reciprocal understanding through linguistic and non-linguistic communication
- (3) From the perspective of Japan and Nagasaki, Asian research that forges a new relationship between the self and the other that will serve as a basis for the study of global humanities and social sciences
- (4) Public policy research to create global public value
- (5) Theoretical and practical research related to peacefully contributing to promoting the abolition of nuclear weaponry
- 2. The restructuring of the humanities and social sciences departments has facilitated more advanced acquisition of fundamental and versatile knowledge and methods pertaining to the global humanities and social sciences, specifically skills for ascertaining the essence of the problems of the multicultural social situation and proposing diverse solutions.
- 3. By comparing and contrasting different societies' experiences and theories and generating new knowledge and value, one can develop outstanding abilities suitable for conducting independent research and becoming a highly specialized professional.

## Curriculum Organization and Implementation Policies (Curriculum Policy (CP))

Based on the educational philosophy, education and research aims, and the DP, we established a policy to form the educational curriculum as follows in order to train researchers and highly-skilled professionals equipped with international communication skills.

## [Policy on organizing an educational curriculum/policy to determine educational content and methods of implementing education]

To acquire creative knowledge and outstanding abilities in the global humanities and social sciences through research supervision based on multilateral viewpoints comprising a research supervision team composed of specialists in diverse fields across five departments.

- To acquire more advanced and creative knowledge and fundamental and versatile methods pertaining to global humanities and social sciences, we build a foundation comprising skills for ascertaining the essence of the problems associated with the multicultural social situation from the perspectives of the Sociocultural Research Department, Linguistic Research Department, and the Japan, Nagasaki, and Maritime Area Studies and Asian Research Department. Additionally, we organize lectures (running in the first semester of the first year) that build a foundation in skills for proposing diverse solutions that lead to the generation of new knowledge and value from the perspective of Public Policy Research Department and the Abolition of Nuclear Arms and Peace Studies Department.
- To organize seminar subjects (running throughout the first and second years), to clarify the aims, significance, and methods of each individual student's research topic, and to aim for a more advanced level of skills for ascertaining the essence of the problems and proposing diverse solutions.
- Based on the research results acquired through the study of seminar subjects and toward advancing further analysis and consideration, the objective is to implement research supervision (running throughout the third year) in order to facilitate the composition of a doctoral dissertation.

#### [Policy on methods of assessing study results]

Assessment of study results will follow the performance assessment method indicated in the syllabus for each taught subject (e.g., regular examinations, reports, and in-class presentations) and will be conducted fairly and strictly. Doctoral dissertations will be assessed via dissertation review and the final examinations.
